

# Älmhult Fights Cancer Race, 6 May 2023

## Terms and Conditions for Participation in the Race

## Section 1 (About the Race)

1.1 Älmhult Fights Cancer Race 2023 ("Race") is organized by IKEA Älmhult AB in collaboration with Elmhults Sport Club ("Organiser").

1.2 The Race is divided into the following categories for participation:

i) 5 Km

ii) 10 Km

iii) 21 Km

## Section 2 (Participation and Registration)

2.1 Every Participant intending to participate in the Race shall be registered in <u>Älmhult Fights</u> <u>Cancer registration at RaceID</u>. The Participant submitting the registration must be at least 18 years old.

2.2 When registering a non-refundable registration fee of 150 SEK for 5 Km, 200 SEK for 10 Km, and 250 for 21 Km (including applicable taxes) per Participant shall be paid. Registration cannot be cancelled or transferred to another individual.

2.3 Participants can register friends and family members, subject to their consent to comply with these Terms and Conditions, and, if the registration concerns a Participant under the age of 18 ("Child Participant"), the consent of the Child Participant's parent or legal guardian. Participants shall be able to demonstrate such consent when required by the Organiser.

2.4 Approval of registration shall be at the sole discretion of the Organiser.

2.5 Participant should not be suffering from any contagious disease, COVID-19 or related symptoms like cough and cold.

## Section 3 (Rules for the Race)

Participants shall comply with the following:

3.1 Reasonable instructions of the Organiser in relation to the conduct of the Race, including any safety instructions.

3.2 Display the registration number provided by the Organiser.

3.3 Be present at least 15 (fifteen) minutes before the start of the Race and run along the track set up by the Organiser.

3.4 Comply with any laws applicable to the Participants in relation to the Race.

3.5 Be aware and comply with all traffic rules and regulations during the Race.

3.6 Not to bring pets or items like posters, strollers etc.

3.7 Not to obstruct other Participants of the Race or create nuisance.

3.8 Not to damage property of others, leave garbage behind.

3.9 Not to display religious or political views or other statements that could be considered as offensive.

## Section 4 (No Prize Money)

4.1 The entire registration fee is intended to be donated by the Organiser for charity purposes in furtherance of cancer research. As such, there is no prize for the Participants of the Race.

## Section 5 (Changes or Cancellation)

5.1 The Organiser shall be entitled to change the date or time of the Race or to cancel the Race. In case of cancellation of Race is due to convenience of the Organiser, the Organiser shall make reasonable endeavors to reschedule the Race. There shall be no refund of any registration fees under any circumstances.

## Section 6 (Child Participant)

6.1 Where a Child Participant is registered, the parent or legal guardian shall either accompany the Child Participant as a Participant, or make sure the Child Participant is kept under sufficient supervision throughout the Race.

## Section 7 (Personal Data)

7.1 The Organiser may be required to process personal data of the Participants during the registration process and conduct of the Race. The Organiser shall process any such personal data in compliance with applicable laws on data protection.

## Section 8 (Liability of Organiser)

8.1 The Organiser shall comply with all applicable laws in relation to the Race.

8.2 The Participants take part at the Race at its own risk. The Organiser does not take any responsibility for any injuries, accidents or other ailment suffered by the Participants during the Race.

8.3 The Organiser has not procured any insurance for the Participants for any injuries, accidents, or other ailment in relation to the Race and any such insurance may be procured by the individual Participants.

8.4 The Organiser does not take responsibility for loss of possession of Participants including any possession left behind by the Participants.

8.5 The Organiser shall not be liable to the Participants for direct, indirect, or consequential damages of any kind. In any case, the maximum aggregate liability of Organiser under this Agreement shall not exceed SEK 10,000.

## Section 9 (Governing Law and Dispute Resolution)

9.1 This Agreement shall be governed by Swedish laws. Unresolved disputes between any Participant and the Organiser, shall be subject to jurisdiction of Swedish courts.
